# FROM THE PRESIDENT OF THE BOARD

On behalf of the Board of Managers, I am pleased to present to you the McLennan County 9-1-1 District's Annual Report for 2018. This is an overview of key results from fiscal year 2018 and includes operational highlights accompanied by supplemental financial reports. In addition, this report provides the staff an opportunity to communicate its efforts in providing you the best 9-1-1 services available.



I am also pleased to share that for fiscal year 2018, MCEAD once again received an unmodified opinion from its auditors. The audited *Statement* 

of Net Position and Governmental Fund Balance Sheet accompanied by the Statement of Revenues, Expenditures, and Changes in Net Position are included as a part of this report, confirming the District continues to remain financially strong.

MCEAD 9-1-1 serves over 250,000 people in 21 jurisdictions throughout Central Texas, including suburban and rural populations in and around McLennan County. On any given day, telecommunicators within the MCEAD 9-1-1 service area field more than 450 calls for help. When a caller dials 9-1-1, the call is routed to one of 8 communication centers. These public safety answering points, or PSAPs, act as the first point of contact for people reporting fires, crimes, injuries, and other emergencies. We are honored to provide the advanced technologies and effective training programs that help keep our neighbors, visitors, and families safe.

I urge you to spend some time reviewing this report. I also invite you to visit our website, <u>www.mcead911.org</u>, for additional information. The District welcomes questions and comments from its members regarding 9-1-1 services or the District's future direction. # FY 2017 – 18 PROGRAM OPERATIONS

#### Robert Leathers, ENP Program Operations Manager

McLennan County 9-1-1 would normally have been replacing 9-1-1 call-taking CPE on a five-year rotational basis which would have fallen during the 2017-2018 budget year. But with approval for a new emergency backup/training facility to be built during the 2018-2019 budget year, it was decided to back up the replacement until the new facility is completed.

Some of the back-room equipment has been in use since the current vendor's equipment was initially installed. All District personnel would devote a lot of their time researching information for not only the new building but all back-room equipment as well as a new network in preparation for the 2018-2019 budget year. When the first call is answered on the new state of the art 9-1-1 call-taking CPE, all associated processing equipment will also be state of the art.

#### Annual Cell Tower Audit

The annual cell tower audit saw major procedure changes during the 2017-2018 year. In the past, the audit relied heavily on inference based on a manual review of the number of transferred 9-1-1 calls, estimated population, number of structures and major roads that fell within the projected coverage area of each cell tower sector in McLennan County.

The new audit procedures are based on actual latitude/longitude of the wireless 9-1-1 caller for each call originating within McLennan County and comparing these coordinates to which PSAP actually received that call. We quickly learned that there were cell towers in McLennan County that had a 100% accuracy rate while other remote towers had a close to a 0% accuracy rate on the few calls that were routed through them.

We have started the process of making the changes needed to ensure all wireless 9-1-1 calls are routed to most appropriate PSAP. This new procedure eliminates the need for an annual cell tower audit and shifts the focus to allowing monthly comparisons that allow routing change requests to be completed on an on-going basis.

# **TECHNICAL ACCOMPLISHMENTS 2018**

#### Gary Jones Technical Operations Specialist

MCEAD District partnered with Intrado, our current CPE provider, and installed, implemented and trained all 9-1-1 call takers to accept and respond to text to 9-1-1 calls within McLennan County jurisdiction. This project required equipment upgrades, hardware additions, new software, and new router configurations.

By utilizing our current remote database network, this gave us the ability to provide texts to the correct responding dispatch entity without installing an additional network, saving this expense and interface workarounds.

Although texting is a small portion of the overall annual 9-1-1 volume, it has proven to be a valuable asset at all PSAP's. After the installation was achieved and in-house testing was completed and satisfactory, MCEAD pushed out an informational campaign utilizing billboards in conjunction with movie theaters and radio advertisements to make the public aware of the availability of text to 9-1-1.

The public awareness presented slogan from the 9-1-1 District states to all of our citizens when contacting 9-1-1 emergency services: "Call if you can and text if you can't".

# **PUBLIC EDUCATION / AWARENESS**

The McLennan County 9-1-1 District maintained its commitment to providing 9-1-1 public education to citizens countywide. The District implemented a media campaign that ran in movie theaters during the December and summer sweeps months that promoted calling 9-1-1 only in emergencies and administered a radio campaign during the month of April. The agency's relationships with individual communications centers throughout the county ensured that our combined efforts heightened awareness about the 9-1-1 system in McLennan County. The District also continued its partnerships with area fire departments, police departments, and EMS providers in order to disseminate the 9-1-1 message.

During FY 18 the District supported the crime prevention efforts of National Night Out events offered by several cities, in addition to the endeavors of area fire departments during Fire Safety Education Month in October.

The 9-1-1 Public Education program proved to be very effective, reaching out to thousands of children and adults. MCEAD participated in and/or distributed materials for health and safety fairs throughout the year and participated in holiday parades. Additionally, MCEAD has worked in many of the schools and youth organizations with the Cell Phone Sally program, speaking and providing educational materials to over 5,000 students.



# **TELECOMMUNICATOR APPRECIATION**

McLennan County 9-1-1 strives to express its appreciation to 9-1-1 telecommunicators through a variety of different avenues during the year. In recognition of Telecommunicator Week in April, the District presented t-shirts along with 4 movie tickets to each of the 9-1-1 telecommunicators. The District also recognized telecommunicators on 9-1-1 Day by giving gourmet popcorn to each one and during the holiday they were given customized jars of candy.



# **TELECOMMUNICATOR HONORS**

The **Silent Hero Certificate of Recognition** is presented to an individual telecommunicator in recognition of his/her exceptional professionalism in the field of public safety. It also acknowledges the special contributions of telecommunicators whose daily performance is an inspiration and example to others.

# TRAINING

McLennan County 9-1-1 hosted the APCO training class "Bullying and Negativity in the Communications Center" on May 21, 2018 and repeated on July 17, 2018. This was an informative class that defined bullying and how it affects everyone in the workplace. The number of U.S workers affected by bullying is a staggering 65.6 million. The course also gave students a better understanding on how to combat negativity in the communications center. Both courses were held at the McLennan County 9-1-1 training facility.

Additionally, the District continues to partner with the Waco Police Department and McLennan Community College to present the TDD/TTY Training Classes. This joint effort has proven to be beneficial to each PSAP served by MCEAD because the TDD/TTY classes are now available on an as-needed basis. Other areas of training include new-hire and Power 9-1-1 Training and Text to 9-1-1 Training.

#### **Financial Management**

The McLennan County 9-1-1 Emergency Assistance District (MCEAD) was formed and confirmed by the voters of McLennan County on August 8, 1987, to administer and provide communication procedures and facilities to make possible the quick response for emergency services. The District operates under the provisions of the State of Texas. It operates under a Board of Managers - Administrator form of government which carries out its responsibilities.

The District prepares its basic financial statements in conformity with generally accepted accounting principles promulgated by the Government Accounting Standards Board (GASB) and other authoritative sources identified in the Statement on Auditing Standards No. 69 of the American Institute of Certified Public Accountants.


