I am also pleased to share that for fiscal year 2019, MCEAD once again received an unmodified opinion from its auditors. The audited *Statement* 

of Net Position and Governmental Fund Balance Sheet accompanied by the Statement of Revenues, Expenditures, and Changes in Net Position are included as a part of this report, confirming the District continues to remain financially strong.

MCEAD 9-1-1 serves over 250,000 people in McLennan County and its 21 municipalities. Over the years, we have made it our mission to build and maintain robust, reliable 9-1-1 systems — and as technologies, populations, and public communication practices continue to evolve, so do our 9-1-1 communication systems. In that vein, one of the highlights of the past year has been the completion of the District's back-up 9-1-1 facility, enhancing the 9-1-1 system in McLennan County. Because of this new structure, if a 9-1-1 call center has need to evacuate its facility, its personnel can relocate to this building and continue to receive 9-1-1 calls and carry out its radio and dispatch operations.

## FY 2018 – 19 PROGRAM OPERATIONS

#### Robert Leathers, ENP Program Operations Manager

After holding off on CPE replacement until construction of the backup facility was completed, District staff spend much of FY20108-2019 researching CPE, network and ancillary 9-1-1 options; selecting vendors; and installation of the new equipment.

With the opening of our new backup facility came the need for new operation procedures. Once the CPE was installed at the backup facility, District staff prepared it for occupation and use by McLennan County PSAPs and document the features and procedures that have changed due to the new equipmnet.

#### **Annual Cell Tower Audit**

The annual cell tower audit, which underwent major procedure changes during the FY 2017-2018 year, had its new procedures tweaked during FY 2018-2019 to further ensure calls are being routed to the most appropriate PSAP.

The District sought to ensure that tower faces that a 100% accuracy rate of calls delivered to the most appropriate PSAP continued to operate at that rate and the tower faces that would benefit by changing its PSAP routing had those changes made.

Since this process has changed from an annual to an on-going, the changes are most in a timelier manner. The addition of a new MIS package will allow this process to be streamlined even more. We can now respond faster to needed call routing changes created by the addition of new subdivisions or even routing changes due to construction.

### **TECHNICAL ACCOMPLISHMENTS 2019**

#### Gary Jones Technical Operations Specialist

MCEAD District historically replaces all 9-1-1 CPE equipment and associated networks approximately every five to six years. 2019 fell within that window of time, although the time frame was extended approximately a year for equipment change-out, due to weather and unavoidable circumstances for the completion of the new back-up facility, located at 109 Burnett Ct.

The upgrade of new CPE equipment required a scalable fiber network that replaced the outdated and unsupported Opteman fiber network. AT&T's lan/wan replacement was its ASE (AT&T switched Ethernet) platform that not only added sizeable speed choices, it also provided the District with NextGen configuration options necessary to point our host sites to aggregation gateways required by NextGen service providers.

Along with the upgraded ASE network, all new Cisco routers were installed, configured, and tested at both host sites including all remote PSAPs. The District had the option to re-use the existing wireless backup coaxial cable and 4G/LTE transceivers, only requiring new 4G/LTE wic cards for new supported Cisco routers. All wireless backup networks were reinstalled, turned up and tested, getting us prepared for the installation and deployment of new 9-1-1 CPE equipment slated for the end of calendar year 2019.

## **PUBLIC EDUCATION / AWARENESS**

#### Joanne Gilliam, ENP Public Education & Training Coordinator Public Educators of Texas President Elect

The McLennan County 9-1-1 District maintained its commitment to providing 9-1-1 public education to citizens countywide. The District implemented a media campaign that ran in movie theaters during the December and summer sweeps months that promoted calling 9-1-1 only in emergencies and Text to 9-1-1. The agency's relationships with individual communications centers throughout the county ensured that our combined efforts heightened awareness about the 9-1-1 system in McLennan County. The District also continued its partnerships with area fire departments, police departments, and EMS providers in order to disseminate the 9-1-1 message.

During FY 19 the District supported the crime prevention efforts of National Night Out events offered by several cities, in addition to the endeavors of area fire departments during Fire Safety Education Month in October.

The 9-1-1 Public Education program proved to be very effective, reaching out to thousands of children and adults. MCEAD participated in and/or distributed materials for health and safety fairs throughout the year and participated in holiday parades. Additionally, MCEAD has worked in many of the schools and youth organizations with the Cell Phone Sally program, speaking and providing educational materials to over 5,500 students.



### **TELECOMMUNICATOR APPRECIATION**

McLennan County 9-1-1 strives to express its appreciation to 9-1-1 telecommunicators through a variety of different avenues during the year. In recognition of Telecommunicator Week in April, the District presented t-shirts along with hosting a family day at the Cameron Park Zoo. The District also recognized telecommunicators on 9-1-1 Day by giving gourmet popcorn to each one and during the holiday they were given customized insulated lunch bags.



## **TELECOMMUNICATOR HONORS**

The **Silent Hero Certificate of Recognition** is presented to an individual telecommunicator in recognition of his/her exceptional professionalism in the field of public safety. It also acknowledges the special contributions of telecommunicators whose daily performance is an inspiration and example to others.

## TRAINING

McLennan County 9-1-1 hosted the Denise Amber Lee Foundation's "*A Victim's Plea*" training course on August 26, 2019 and repeated on August 27, 2019. In this full-day course, students were exposed to a riveting, emotional roller coaster of critical 911 failures that occurred the night Denise was kidnapped, raped, and murdered. Nathan Lee, founder and President of the Denise Amber Lee Foundation, and a 911 professional tied together the elements of the Denise Amber Lee tragedy. This was a positive and uplifting presentation, students learned of the obvious failures that day to the more in-depth concepts such as leadership, hiring, training and encouraging employees in a communications center. This course was held at the MCEAD training facility.

Additionally, the District continues to partner with the Waco Police Department and McLennan Community College to present the TDD/TTY Training Classes. This joint effort has proven to be beneficial to each PSAP served by MCEAD because the TDD/TTY classes are now available on an as-needed basis. Other areas of training include new-hire and Power 9-1-1 Training and Text to 9-1-1 Training.

The District operates under the provisions of the State of Texas. It operates under a Board of Managers – Administrator form of government which carries out its responsibilities.

The District prepares its basic financial statements in conformity with generally accepted accounting principles promulgated by the Government Accounting Standards Board (GASB) and other authoritative sources identified in the Statement on Auditing Standards No. 69 of the American Institute of Certified Public Accountants.


