FY 2019 - 20 PROGRAM OPERATIONS

McLennan County 9-1-1 would have traditionally been following up the replacement of the 9-1-1 call-taking CPE with monitoring activities and getting use to the differences between the old and new CPE. These activities would have meant spending more time than normal at each of the McLennan County PSAPs. But, in the world of covid as experienced in 2020, PSAP visits were kept to an absolute minimum. District personnel had to learn new methods of performing the equipment monitoring and testing.

Fortunately, the new emergency backup and training facility had already instigated research into this very area of expertise by the District. District personnel are now able to view all activity for a PSAP by being logged into that PSAP remotely. This past year has been a year of experimentation. We have been learning which procedures produce the best testing results in the most efficient manner.

Operations has also continued adjusting its cell tower monitoring program. This program is a major reason the number of wireless 9-1-1 calls that have had to be transferred to a different PSAP continues to drop. The wireless providers have announced that starting next year, their process for updating these towers will become easier to accomplish while being more accurate.

The mapping project is continuing to progress as each address range for every road centerline is reviewed for accuracy and updated, as required. Every road centerline is reviewed to verify it is located in the center of the road. Every structure is aligned to the location of the address. Finally, the low-high address ranges are compared to the Master Street Address Guide to verify that each represent the centerline data correctly. This project finished the year about 85% complete. Once complete, this project will be transformed into a maintenance program to ensure that a high quality and accurate map is presented to our PSAPs.

9-1-1 EQUIPMENT AND TECHNOLOGY REPLACEMENTS

The McLennan County 9-1-1 District completed the cycle of new equipment and network replacements in December 2019. This is planned, budgeted, and implemented approximately every 5 to 6 years, providing the citizens of McLennan County with the most dependable and current 9-1-1 infrastructure. The District completed a hardened backup facility which not only has the capability of withstanding a direct tornadic hit but gives all PSAPs a backup location to answer and transfer their respective 9-1-1 calls. This new facility also provided the 9-1-1 District the option of moving our host B location from the 2nd floor Sheriff's office IT room to a more hardened location across the parking lot from our District administration facility in Woodway.

Within the new upgraded infrastructure an AT&T-ASE fiber network was implemented to include all PSAPs within McLennan county. Not only does this network provide scalable state of the art bandwidth, but it also gives the District the ability to transition to phase 1 of Next-Gen 9-1-1 with minimum modifications. All new servers, workstations, routers, firewalls, monitors, and other associated equipment were included in this upgrade and total replacement project.

Although we must get creative on keeping all 9-1-1 calls flowing and uninterrupted during this equipment and network replacement phase, the result of a secure, dependable, and redundant 9-1-1 system is always the end goal and our number one priority at MCEAD.

PUBLIC EDUCATION / AWARENESS

The McLennan County 9-1-1 District maintained its commitment to providing 9-1-1 public education to citizens countywide. The District implemented a media campaign that ran on local television stations during the Spring and Summer sweeps months that promoted *Calling 9-1-1 Only in Emergencies* and *Text to 9-1-1*. District Staff also created Facebook messages and videos to promote 9-1-1 awareness. The agency's relationships with individual communications centers throughout the county ensured that our combined efforts heightened awareness about the 9-1-1 system in McLennan County. Additionally, the District continued its partnerships with area fire departments, police departments, and EMS providers in order to disseminate the 9-1-1 message.

During fiscal year 2020 the District supported the crime prevention efforts of National Night Out events offered by several cities, in addition to the endeavors of area fire departments during Fire Safety Education Month in October.

The 9-1-1 Public Education program proved to be very effective, reaching out to thousands of children and adults. In the Fall of fiscal year 2020 (prior to COVID-19), MCEAD worked in many of the schools and youth organizations with the Cell Phone Sally program, speaking and providing educational materials to over 5,500 students.









TELECOMMUNICATOR APPRECIATION

McLennan County 9-1-1 strives to express its appreciation to 9-1-1 telecommunicators in an assortment of different approaches throughout the year. In recognition of Telecommunicator Week in April, the District presented t-shirts along with tool kits to each telecommunicator. In September on 9-1-1 Day, the District recognized each telecommunicator with a gift of gourmet popcorn, and during the holidays each was given a customized insulated tumbler.



TELECOMMUNICATOR HONORS

The **Silent Hero Certificate of Recognition** is presented to an individual telecommunicator in recognition of his/her exceptional professionalism in the field of public safety. It also acknowledges the special contributions of telecommunicators whose daily performance is an inspiration and example to others. Like so many other functions in 2020, the state conference where these telecommunicators are customarily recognized was cancelled due to Covid-19. The unfortunate result of this was that no awards were presented to those behind-the-scene heroes so deserving of such recognition for their contributions and dedication that cannot adequately be measured.

TRAINING

Due to the Covid-19 Virus, in-person training was not available in FY20. McLennan County 9-1-1 contracted with **The Public Safety Group** to provide *Training on Demand*. This program allowed PSAPs in McLennan County unlimited access to the Training-on-Demand library. The training included a variety of topics including:

- Calming techniques
- the 5 W's
- Officer Involved Shootings
- Front Line Leaders
- PTSD and many others.

The District also created two-minute training videos that were accessible on the MCEAD website as well as the MCEAD Training Facebook page.

Additionally, the District continues to partner with the Waco Police Department and McLennan Community College to present the TDD/TTY Training Classes. This joint effort has proven to be beneficial to each PSAP served by MCEAD because the TDD/TTY classes are now available on an as-needed basis. Other areas of training include new-hire and Power 9-1-1 Training and Text to 9-1-1 Training.

WHAT IS A 9-1-1 DISTRICT?

The McLennan County 9-1-1 District is not part of any city, county, phone company, police or fire department, or other entity. It does not operate call centers, nor does it own a single emergency vehicle. Rather, it is a stand-alone governmental body that exists solely to bring efficiency and excellence to our 9-1-1 service through:

Strategic Planning Systems and Processes Management Leading Edge Technology Legislation and Regulatory Activities

Training Equipment and Monitoring Public Education Database Management

Geographic Information Systems

There are more than two dozen emergency communications districts throughout the state of Texas. Emergency communications districts, commonly referred to as 9-1-1 Districts, are charged with provisioning, maintaining, enhancing, and improving 9-1-1 services for wireline, wireless, and emerging technologies.

Because of the district, McLennan County citizens can rest assured they have state-of-the-art 9-1-1 emergency infrastructure at their fingertips. Progressive public communication in mass media, community events, and targeted school programs keep families aware of ever-changing technology and how it affects their calls for help in an emergency.

MAKING A DIFFERENCE AT THE LOCAL LEVEL

Established in 1987 through a voter referendum placing 9-1-1 operations under local control and management, McLennan County 9-1-1 is governed by a board of managers who are elected or appointed by the jurisdictions we serve. The local approach to delivering 9-1-1 services provides us the ability to quickly adapt to changing technologies and trends, and to constantly refine our services in order to better serve the needs of the local communities.
